Call for a Mass Meeting

As Chairman of the Bath County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Deborah Mills, do hereby issue this notice and call for a Mass Meeting to be held on Thursday, March 21, 2024, at 6:00 pm, at the Bath County Courthouse, at 65 Courthouse Hill Road, Warm Springs, Virginia 24484 for the following purposes:

- (1) Elect Delegates and Alternates to represent Bath County at the Republican Party of Virginia's 2024 Quadrennial Convention which shall be held at the Hampton Roads Convention Center on May 31 and June 1, 2024. *The Bath County Republican Committee shall have a maximum of 65 delegates.* At the State Convention, the Delegates will (a) select two Electors At-Large to be voted for in the presidential election on November 5, 2024; (b) elect a State Chairman, (c) nominate a National Committeeman and National Committeewoman and (d) to transact such other business as may properly come before the Convention; and
- (2) Elect Delegates and Alternates to represent Bath County at the Sixth Congressional District Committee of the Republican Party of Virginia Convention which shall be held on Saturday, May 11, 2024 at the Rockingham County Fairgrounds 4808 S. Valley Pike, Harrisonburg, VA or its alternate site, starting at 10:00 A.M. local time. *The Bath County Republican Committee shall have a maximum of 65 delegates.* At the District Convention, the Delegates will elect a District Chairman, three Regional Vice-Chairmen, and three Representatives to the State Central Committee. Said Delegates will also nominate an elector to vote for the Republican candidate for President and transact such other business that may properly come before the Sixth Congressional District Republican Convention; and
- (3) To transact such other business that may properly come before the participants in a mass meeting.

Qualifications for Participation

All legal and qualified voters of Bath County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates seeking election as Delegates and Alternates to the State Convention and the 6th Congressional District Convention, as Bath County Republican Committee Chairman and as Bath County Republican Committee members are required to file a form by US Mail to Mrs. Karen Allen, at the Committee's mailing address, Post Office Box 102, Warm Springs, Virginia 24484.

Filing forms must be received no later than 5:00 pm, Monday, March 18, 2024. The filing form for convention candidates and Committee members may be found below on this Call. Postmarks do not govern.

Mass Meeting Registration

Photo ID is required for all participants at the Mass Meeting. It would be very helpful if participants bring their Voter ID Card with them.

Registration will begin at 5:30 pm. The Mass Meeting will be called to order at 6:00 pm sharp! Persons who have not registered or are not in line to register by 6:00 pm will have lost their opportunity to participate in the Mass Meeting.
