



OFFICIAL CALL
Mass Meeting
The Republican Party of Alleghany and the City of Covington
of the Republican Party of Virginia

As Chairman of Alleghany County and The City of Covington Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Tiffany K. Snedegar, do hereby issue this call for a Mass Meeting to be held at the Alleghany Highlands Regional Library, 406 W. Riverside St., Covington, VA 24426, or it's alternate site, beginning at 10:30 a.m. local time on April 6, 2024 (with registration opening at 10:00 a.m.) for the following purposes:

1. To elect a Chairman for the Alleghany County and City of Covington Republican Committee;
2. Electing up to 265 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on May 31 - June 1, 2024, at Hampton Roads Convention Center, 1610 Coliseum Dr, Hampton, VA 23666. Convening on 5/31 at 2:30 pm and on 6/1 at 10:00 a.m. for the purpose of:
 - a. Selecting two (2) Electors At-Large to be voted for in the presidential election November 5, 2024;
 - b. Electing at State Chairman;
 - c. Nominating a National Committeeman and National Committeewoman
 - d. the transaction of other business as may properly come before the Convention.

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes cast for Governor and President at their last election, so that Alleghany/Covington is entitled to 53 Delegate Votes;

3. Electing up to 265 Delegates and an equal number of Alternates to the Sixth Congressional District Republican Convention, to be held on May 11, 2024 at the Rockingham County Fairgrounds, 4808 S. Valley Pike, Harrisonburg, VA or it's alternate site, beginning at 10:00 a.m. for the purposes of:
 - a. Electing a Chairman for the Sixth Congressional District of the Republican Party of Virginia;
 - b. Electing three (3) Regional Vice Chairman for the Sixth Congressional District of the Republican Party of Virginia;
 - c. Electing 3 members to the State Central Committee of the Republican Party of Virginia;
 - d. Nominating an elector to vote for the Republican candidate for President, and
 - e. The transaction of such other business that may properly come before Sixth Congressional District of the Republican Party of Virginia Convention.

4. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Alleghany County or The City of Covington under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Voters may be required to produce personal identification such as a valid photo ID that is acceptable for voting purposes in order to participate.

Filing Requirements

Candidates for election for unit chairman, vice-chairman, treasurer and secretary. Members of the Alleghany County and Covington City Republican Committee, or as a delegate or alternate delegate to the Republican Party of Virginia State Convention and/or the Sixth Congressional District Republican Convention at said mass meeting shall file a written statement by mail or in person, to C. Tiffany K. Snedegar, 807 Kanawha Trail, Covington, VA 24426, which must be received not later than 5:00 p.m. March 30, 2024 and accompanied by any fees required. Postmarks shall not govern.

Candidacy filing fees are as follows:

- Unit Chairman - No filing fee.
- Unit Committee Member – \$20.00 dues for [1 year(s)]. (To be paid with pre-filing).
- Delegate/Alternate Delegate to the Republican Party of Virginia State Convention - \$45.00 registration fee.
- Delegate/Alternate Delegate to the Sixth District Republican Convention - \$25.00 registration fee.

Please make checks payable to the Republican Party of Alleghany/Covington.

Uncontested Offices/Cancellation of Mass Meeting

If no more than one candidate files for election to any office to be voted upon at the mass meeting, that candidate will be declared elected. If fewer than the maximum number of unit committee members that

Alleghany County and City of Covington Republican Committee has established pre-file, all properly pre-filed candidates shall be declared elected to the applicable unit committee membership position. If fewer than the maximum number of Delegates that Alleghany County and City of Covington Republican Committee is entitled to at any convention pre-file, all properly pre-filed candidates shall be declared elected. If there are no contested offices to be voted upon at the mass meeting, then no mass meeting will be held.

Registration Fees for Mass Meeting & Convention

There is no registration fee to participate in the Alleghany County and City of Covington Republican Committee Mass Meeting.

There is a registration fee of \$45.00 for each delegate/alternate delegate elected to the Republican Party of Virginia State Convention. Fees are requested to be paid at the time of filing for election as a Delegate. Please make checks payable to the Republican Party of Alleghany/Covington, which will forward the registration fee to the Sixth Congressional District Republican Convention.

There is a voluntary registration fee of \$20.00 for each delegate/alternate delegate elected to the Sixth Congressional District Republican Convention. Fees are requested to be paid at the time of filing for election as a Delegate. Please make checks payable to the Republican Party of Alleghany/Covington, which will forward the registration fee to the Sixth Congressional District Republican Convention.
